
PAST EVENTS

RECORD ATTEMPT PLANNED FOR A TR-3A by Dennis Riley Georgia Triumph Assn.

When Ken Richardson was at the VTR National, he told a group of us about a 1959 record attempt he tried in Monza, Italy.

He took a production 1959 TR-3A from England and drove it to Monza, which has a high banked oval course. He gathered 10 college students as drivers and attempted to run the production car at an average speed of 100 mph for 100 straight hours (over four days). The idea was to show the reliability of the Triumph Sports Car.

As Ken put it, "One of the bloody students blew the engine in the 94th hour and we never completed the run". However, you may find the event mentioned in books and articles because the TR-3A did set many new records during the run. But Ken was not satisfied that it never made the 100 hours at 100 mph.



Sitting around in a local pub, the idea to try it again 30 years later in a 30 year old TR-3A, began to take The latest inshape. formation from Paul Richardson is that a new attempt will be made in 1989 and this time they are confident of finishing what they started ou to do back in 1959.

Paul has already selected the 1959 TR-3A to make the run. It will be completely torn down and re-assembled with all new parts. Paul also has lined up the drivers, contacted some major sponsors, lined up some of the original support team and has everything well under way.








VTR's First Southern Chapter



Dear Craig and Jane:

I apologize for not contacting you sooner regarding your questions about the pending mandatory seat belt legislation and particularly its application to antique cars. I had to call Lt. Colonel Billy Hughes at the Mississippi Department of Public Safety to find out which bill (seven separate bills have been introduced mandating seat belt usage) he was reading from at the public hearing.

Enclosed are copies of House Bill No. 381 and Senate Bill No. 2366 both of which contain proper wording. You will note the underlined wording in both bills with particular reference to "Federal Motor Vehicle Safety Standard 208." Lt. Colonel Hughes informs me that this language restricts the proposed mandatory seat belt law from affecting any automobiles manufactured prior to 1968. Consequently I believe the legislation is properly worded to protect our antique car lovers.

If you have any further questions or if I can be of greater assistance, please do not hesitate to contact me.
